AGREEMENT FOR UNIVERSITY OF SAN DIEGO LAW STUDY ABROAD PROGRAMS

This agreement between the Univ of San Diego School of Law (USD) and the participant consists of this page, the current Summer Law Study Abroad supplementary information sheets and the [Academic Rules of USD Law School](#). Items placed on the USD main web site are not part of this contract other than the Academic Rules of USD Law School. This agreement constitutes the entire agreement between USD and participant, and may be modified only in writing.

1. USD promises to provide the participant with the academic program set forth in the above documents via the Study Abroad Web Site only.
 2. USD will NOT provide participant(s) with medical, health, medical repatriation of remains travel insurance or any type of insurance while on the USD summer abroad program(s). All travel insurance must be secured personally by the participant. Students are **required to provide** USD with a copy of their insurance card that covers them for the entire time of their selected program(s) before acceptance is granted.
 3. USD will process the participant's double-entry visa for Russia. All other travel documents and any desired inoculations will be obtained by participant and at the participant's expense.
 4. USD does not provide housing for participants. Housing is at the participant's option. USD facilitates arrangements between the participant and campus housing providers for Dublin, London, and Oxford. For Barcelona, Florence, Paris and Russia, where we do not have campus housing providers, students find their own housing with **some help** from the USD web site and USD local office in the selected country(s) when it opens (about 1 week prior to the start of the foreign program(s)). If any disagreement arises about the housing, or about property damage or personal injury connected to the housing, the participant will resolve that disagreement with the housing provider, and will hold USD harmless for any damage that might result.
 5. Participant realizes that conditions of safety, housing, access to public accommodations, and cultural expectations are different in foreign countries. Participant acknowledges that USD has advised participant to become familiar with these risks through commercially prepared guidebooks so that (s)he can intelligently decide whether to take the risks involved in foreign study. Participant acknowledges receipt of reference to the latest U.S. Department of State Consular Information Sheet detailing health and safety conditions within the country of the program and has had the opportunity to carefully peruse it.
 6. USD is not responsible for the health or safety of participant, nor for directing participant's medical care. Should participant be incapacitated and unable to direct his or her own medical care, USD will attempt to facilitate the management of that care by the person whose address and phone numbers have been given to USD as the emergency contact. In the event that USD is unable to contact that person, or in the event that emergency care is needed that cannot wait for such contact, participant authorizes USD to authorize medical treatment, or transportation home, at participant's expense if such action seems warranted in the exercise of USD's discretion.
 7. Photos will be taken and questionnaires administered during the program. Participant authorizes USD to use participant's likeness and/or statements in USD's published materials and/or on the Study Abroad web site without compensation.
 8. Participant has reviewed the Guarantee policy and the Refund policy on the Summer Law Study Abroad web site, and agrees to those policies. **And** has also reviewed the Guarantee policy under [Admissions](#), on the Summer Law Study Abroad web site. Participants have also read and agreed to their program sites Refund Policy [Barcelona Refund Policy](#), [Dublin Refund Policy](#), [Florence Refund Policy](#), [London Refund Policy](#), [Oxford Refund Policy](#) [Paris Refund Policy](#), [Russia Refund Policy](#).
 9. This agreement is governed by the laws of the State of Calif. Any litigation about this agreement will be brought only in the state courts of the State of Calif located in the county of San Diego. Both parties consent to jurisdiction and venue there.
 10. Participant shall not be liable to USD for any reason other than breach of contract, or negligent or intentional torts. Participant's liability to USD shall not exceed the amount paid third parties by USD as a result of participant's actions plus the amount USD may retain under the refund policy.
 11. USD shall not be liable to participant for any reason other than breach of contract, or negligent or intentional torts. USD's liability to participant shall not exceed the amount participant paid to USD. USD's consent to this contract is manifested by its delivery.
